ELECTION OF OFFICERS & DIRECTORS

- Pelada FA's Board of Directors must have between 5 and 15 members (currently 7).
- All members of the Board will be elected at the AGM.
- The term length for Board positions will be **two years** unless otherwise specified.
- Each **officer** is limited to **three consecutive terms** in the same office.
- **President, Treasurer**, & ½ of Directors at Large are elected in even numbered years.
- Vice President, Secretary, & ½ of Directors at Large are elected in odd numbered years.

VOTING

See link in the chat to access the electronic ballot

- Up to two members of each family attending the AGM are entitled to cast a vote.
- Coaches, volunteers, board members, and members of staff who are registered with OYSA are also entitled to vote, even if they do not have a player in the the Academy.

ELECTRONIC VOTING PROCESS

- An electronic ballot and summary of actions open to voting will be sent to attendees in advance of the AGM.
- The Meeting Chair will **open discussion** of proposed ballot actions. This is your opportunity to comment, ask questions, address issues, or voice any objections you may have.
- Members of the board will move and second the motion to vote. This is your opportunity to submit your electronic ballot or a revised ballot if you voted prior to the meeting.
- Members will have 30 minutes from opening of voting to submit or revise ballots.
- After voting has closed, ballots will be tabulated and results will be announced at the end of the meeting. The total number of ballots returned will constitute a quorum and a simple majority of the votes cast will be required to approve each action.










ENROLLMENT By Season




- Summer: 21-22 large increase due to record tournament attendance.



DEFINING "PELADA"

The word **Pelada** [pronounced Pay-lah-dah] comes from Brazil and describes an informal game of soccer between friends. Peladas are played everywhere, everyday, motivated by nothing more than love for the game and the sense of community at its core.



FOUR PILLARS OF THE PELADA MODEL

Coaches as Educators: Certified coaches who participate in ongoing education and understand their roles as teachers, role models, and life mentors for children.

Competitive Player Development: Curriculum and club practices designed to improve each player's standard of play and ability to compete at a high level.

Opportunities for All: Players are not cut based on ability. Every player plays at least 50% of each match.

Positive Approach: Inclusive and supportive environments for players, and insistence on fair play.

COMMUNITY GOALS

- Provide positive environments and exceptional playing experiences for young players.
- Train leaders and foster mentoring relationships between players that accelerate personal development.
- Increase and diversify opportunities for competition locally by supporting leagues and hosting tournaments & community events.
- Answer the calls and needs of the community as we continue to develop our programs.

2021-22 HIGHLIGHTS

COACHES

COACH EDUCATION: 21–22 was an excellent year for coach education, with most of our head coaches and many of our assistant coaches leveling up in the course of the year!

- 10 coaches earned the OYSA Futsal 1 & 2 Diplomas
- **5** coaches earned the **USSF D License**
- **3** coaches earned the **USSF C License**
- 1 coach earned the **USSF B License**

We are currently investing in **goalkeeper coach education** to improve our service to goalkeepers throughout the Academy. Several of our coaches will be attending the United Soccer Coaches Goalkeeping Level 1 & 2 diplomas in Portland at the end of August.

2021-22 HIGHLIGHTS

FOUNDATIONS ACADEMY

U8 FOUNDATIONS ACADEMY: We achieved one of our long term goals in establishing a program for players under seven years of age and creating and pathway into our U9-U10 Valley Academy League teams.

38 players age 3-7 participated in the new U4-U8 program format

Summer and Winter programming

Program fees are set below cost, at just \$50-75 per season

The Foundations Academy represents an important first link in our program chain. It will help us cultivate a new branch of the Pelada community, identify and integrate players earlier, and provide vital resources for building our first competitive teams at the U8-U10 age groups. **Feedback so far for Summer 2022 has been overwhelmingly positive!**

2021-22 HIGHLIGHTS

PLAYERS & PROGRAMS

RECORD PLAYER PARTICIPATION: 21–22 set an all time high for number of unique registrations across all programs. **WINTER U15+ TEAMS:** 21–22 also set an all time high for number of teams participating in the high school age groups. **CUP & TOURNAMENT PARTICIPATION:** For the first time, all of our teams age U11 and older participated in postseason cups. Summer tournament attendance also hit an all time high.

- **461 different players** participated in our programs in 2021-22 (**369** players in pre-pandemic 2019-20 season)
- **113 players** rostered on our U15+ Winter/Spring teams (**56** in 2019-20 season)
- **110 players** participated in our Futsal Academy (**72** in 2019-20 season)
- **16 teams** participated in OYSA's postseason cups (**3** in 2019-20 season)
- **12 teams** participated in summer tournaments (**3** in 2019-20 season)

COACH DEVELOPMENT ACADEMY: After putting our youth coaching program on hold during the pandemic, we are very happy to finally reintegrate our youth coaches with our U8 and U10 programs! We have returned with a revised format, reducing the total training contact hours and maximizing the time spent on field mentoring younger players.

28 youth coach Candidates enrolled so far in 2022-23

7 senior staff coaches contributing as CDA instructors



Participation and feedback from our Coach Development Academy families has been excellent. The youth coaches are making tremendous contributions to our summer Foundations Academy, allowing us to boast a 1-to-1 coach-to-player ratio and a super kid-friendly environment!

2022-23 UPDATES

NEW UNIFORMS

HUMMEL KITS & DIRECT KICK PARTNERSHIP: We have signed an agreement with the Hummel brand to supply our uniforms for the next 4+ years and partnered with local soccer shop Direct Kick (now located in South Eugene) for ordering and printing services.

All garments, including extras like hoodies, jackets, and pants will be available to try on and purchase at Direct Kick, meaning more accurate sizing and quicker production.

Direct Kick Soccer Shop is located at 354 E 40th Ave in the shopping center at 40th and Donald in south Eugene.

VEO CAMERAS

MATCH VIDEO & ANALYSIS: We have purchased two Veo cameras and subscriptions to match analysis software. The platform is very impressive and will allow us to provide match footage, highlights, and additional learning resources for ALL of our players and families!


